## Associate Membership

Any person, firm, corporation, or other organized group involved in the construction aggregate industry but does not produce or sell State-approved construction aggregates is deemed eligible otherwise by the Board of Directors to be admitted to Associate Membership. The GCAA Board of Directors has set the Annual Dues at \$1200 per year.
